COMMODORE'S REPORT

This year's AGM saw the election of a Committee which I consider has the potential to improve the sport of Power Dinghy Racing competitively, socially, financially and co-operatively.

The outgoing committee have much to be proud of. Their year ended with the Club in a financially sound state, the 10 h.p. class approved for the 1995 Avon Descent, new recovery boats and equipment, the Blackwood Classic 250 firmly entrenched as a PDRC event and membership steady.

Several long standing committee members chose to seek positions or were not re-elected. To those individuals I, on behalf of the Club, express our genuine thanks for their past service.

I intend that your new Committee be entirely accountable to the members, that you should be kept informed of any decisions or developments and that your concerns and aspirations are heard and acted upon.

At the AGM new WASDA representatives were also elected. To date some members and Northam's Avon Descent Association have indicated to me that they have concerns regarding this representation. I have informed NADA that the representatives were elected constitutionally and I am awaiting their official response.

There are some immediate challenges facing us in 1995/96. The Burswood Clubrooms Project has developed to the stage where financial decisions are imminent, confirmation of the Clubs commitment to this project will need to be established forthwith. The need to resurrect our social calendar is of prime concern, and we need to look seriously at our fundraising activities.

As a scientist I am particularly aware of the current environmental issues and the potential they have to impose restriction on dinghy racing in W.A. With careful attention to these issues I am confident that our River Racing activities can be expanded and I am looking forward to input from our members regarding new venues and challenges.

RULE CHANGES

The following rule changes will become applicable from the 8/8/95 as passed by members at the April A.G.M.

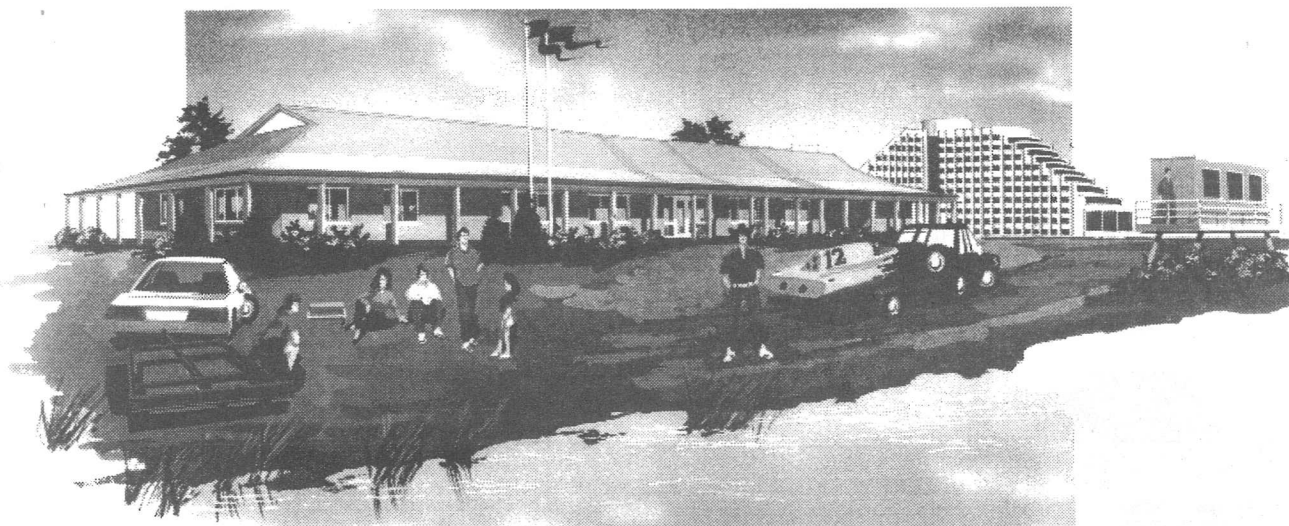
1. Rule 3.1 (e) P.D.R.C. Constitution.

Any member elected for a position on the management committee shall serve for a period of no longer than 24 months from date of election in any one position. They must then retire from the said position for a period of no less than 12 months before becoming re-available for that management position.

2. 10 h.p. drivers who have 20,000 licence points or more can have a co-driver with a minimum 500 licence points.

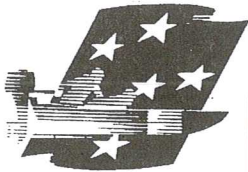
