

### **COMMODORE'S REPORT**

I believe that the result of the election at the AGM represented the wishes and intent of the majority of club members. To change the structure of this committee by means of legal nitpicking is not in the best interests of the Club or the sport and should not be condoned.

In particular the debate over the voting rights of life members should not have impacted on the landslide election victories of the Secretary and Scrutineer, neither of these positions were reliant on proxy votes for success.

The next few months are the busiest time of the year for the committee yet it has become almost impossible to operate efficiently whilst our positions are being contested by others. Every member has the opportunity to stop this instability by reconfirming support for this committee at the June 12th General meeting.

This years racing calender is already looking good; the Nannup Cup is ready to go, and indications so far from the authorities are that the Upper Avon Challenge can be resurrected. New social events such as the "Melbourne Cup in July" are already being put in place and plans are underway for a fund raising raffle.
