At the Special General Meeting held on the 12th June, 1995 the following committee positions were voted on:

Secretary - Kerry Barden, Scrutineer - Greg Barndon, Safety Officer - Peter Hink, W.A.S.D.A. Delegates -Keith Brooker. Glen Skewes

The following proposal was passed by a majority of members:

P.D.R.C. Constitution

10.0 Voting

10.5 No member shall cast more than two proxy votes at any general meeting, special general meeting or annual general meeting.

RULE PROPOSALS

1. I propose that alloy boats be permitted to enter 10 hp Class in river races.

Proposed J. G. Haynes Seconded B. Watson

2. I propose that by the 1st May 1998 all power dinghy competitors must wear helmets carrying Australian Standards 1698 and be of snell dot128 (wetstream) or similar watersport manufactured helmet.

Proposed G. Hall Seconded R. Wilson

The following proposals were passed by members at the June General Meeting:

1. I propose that the entry fee for Rookies be included in the multiple entry fee where one race I.D. number is being used for all craft.

Proposed L. Brooker, Membership No. 328 Seconded G. Paull, Membership No. 174

2. I propose that Rule 18.1 (d) Power Dinghy State Championship, 18.1 (d) Formula 8 and Bathtub State Championships and 19.1 (d) Formula 8 and Bathtub Championships be altered to read:

The Club Champion shall be the competitor who scores the highest number of points in the series.

COMMODORE'S REPORT

The rejection of our application to the Avon River management authority to run the Upper Avon Challenge was very disappointing, especially as the local shire councils and the Dept. of CALM had approved the event. I have no doubt that the AMRA have the best interests of the Avon River and its associated ecosystems as their prime objectives but I am hopeful that by presenting meaningful scientific evidence the Club will be able to make a persuasive argument to re-establish this event. The Club is indebted to ArthurFairhurst for organising the Spit Post Marathon as an alternative event at such short notice.

Meanwhile all members must be acutely aware that we are being watched very closely. Dinghy racing can, I believe, be conducted in a manner that is not harmful to the environment BUT you as competitors must demonstrate this by being ultra-cautious, especially with fuel, when in areas of native vegetation or around waterfowl etc. It is highly likely that riverside refuelling will be disallowed - it would be wise to consider this when designing your next fuel tanks - you may need to either carry sufficient fuel for a days racing or use removable tanks that can be exchanged with another that was filled away from the race area.

It is becoming increasingly harder to find Club members who are prepared to volunteer to officiate at Club events. Yes, I know some of you do a stint in the recovery boats, help with flags or hold a stopwatch but few are prepared to help organise events and/or be a race director. All events require an amount of behind the scenes organisation and it is time more of you became involved to relieve the very considerable burden that is falling on the same few people. At the next General Meeting I will be asking for volunteers for officials for all our races in the coming season, please think seriously about increasing your contribution to the running of these events.

On Sunday June 25th WASDA met for the first time in over a year, I am pleased to be able to report that the meeting was amicable and constructive. Greg Barndon was confirmed as WASDA scrutineer and Lynne Berloth was reappointed as WASDA secretary. The role of WASDA as the governing body for power dinghy racing was reaffirmed but in future the PDRC may have more involvement with race approval applications to local authorities etc. The Blackwood River Sports Club are hoping to re- establish themselves as an active club and hope to be in a position to again be running races in their area in the near future.

Saturday July 29th between 8.00am and 12noon

Sunday July 30th between 12noon and 6.00pm.

NOTE: The Avon book states 6.00am start and practice as far as Emu Falls THIS IS INCORRECT. Practice is allowed only as far as Posselts Ford.

SPIT POST MARATHON REPORT

The race was organized in a rush this year due to the cancellation of the Upper Avon Challenge at the last moment. After getting the go ahead from Marine and Harbours the race time was set for 9am. We were then contacted on the Thursday before the race by the Aquatic Council who told us that due to a yacht race starting at 10am, across the middle of the course, we had to be off the water by 9:30am. The race was then rescheduled for 8am which meant a phone round to all members racing (Thanks Kerry).

On race day we arrived in the cold and dark, fortunately we had the sausage sizzle and hot soup on hand. The race was over two laps this year with support crews running down the beach with ribbons in hand to start their crews underway.

The race started with 34 boats. The water was flat in some places but for the most part choppy and quite lumpy (especially when a rather large catarmaran moved across the middle of the course!). There were however no reports of boats overturning although some competitors did retire early due to the conditions (a slight swell). There was a compulsory stop at Melville Beach to collect another ribbon as well as another compulsory stop at the start/finish line at the end of the first lap where support crew had to run a mini-marathon before crews could start on the second lap, many of which were children and wives who enjoyed the involvment.

22 boats finished, 6 withdrew and 6 did not make the cutoff time at 9:30. Special thanks must go to people who let us use their mobile phones which enabled officials to keep the race under control. Also all people who supplied marshall boats free of charge.

NANNUP CUP 1995

There was not much more than a trickle under the bridge at Nannup on the day before the race, a walk downstream revealed logs, rocks, coffee rock, sand bars, logs, logs and more logs. At this stage we dicovered four electicified fences across the river and things were not looking too good! Much to our relief there was a strong water flow at Jalbarragup, not much depth, but definitely enough to race.

The 10HP drivers made a collective decision not to race because of the low water but this still left a strong field of 24 starters at Jalbarragup on Sunday morning.

Brad Kitcher and Mark Smith in boat 201 were first away in grid 1 and never looked back. By the second checkpoint (Mileyannup ford) 201 had a lead of 4 minutes over Cliff and Sarah Hills in boat 051 with lan and Todd Williamson in 167 15 seconds behind and making ground. Meanwhile 174 the standard boat of Glen Paull and Ray Payne was making its way through the field after drawing the last grid position and was 4th through Mileyannup only a minute later.

By checkpoint 5 (Punch Road) 201 and 167 were still 3 minutes apart and by this stage the Branson boys in 144 had worked very hard to be 3rd sports boat and improving. By now 174 had blitzed the standard class!

Greg and Margot Barndon in 081, David Ritson and Linley Anderson in 192 and Kevan Goodall and Mary Vessels in 037 fought a close battle for the standard places, all three boats finished with faster times than the sports class place getters. Miscalculations leading to an uneccessary stop for fuel cost at least one boat a trophy (eh Kevan?!).

By 4.00pm every boat was home, only 4 craft had withdrawn and the Club sweep boat suffered no damage .

Brad and Mark in 201 took line honours and the fastest time, they averaged 23.6Km/h over the 62Km course. Standard Class winners Glenn and Ray were 1min 35sec behind them and averaged 23.33Km/h.

All in all it was a very successful event - the weather was perfect and a family atmosphere prevailed, in fact there were 5 husband and wife and 3 father and son teams and more ladies competing than ever before.

SIZZLE SAGA

The PDRC sausage sizzle was presented for a trial screening to a select audience at the 1994 Spitpost Marathon by "Fairhurst Enterprises". After a successful takeover bid by "Brooker Productions" it was released for commercial screening at the Burswood venue in November last year and has met with a box office success at 5 subsequent events. Due to the faithful support of snagger connoisseurs posing as dinghy racers, family and friends, the box office PROFITS to date total \$1416.65. Some of these funds (\$337) were used to purchase some essential production equipment - namely the Clubs' new portable gas BBQ and 9Kg cylinder (well it's compact at least, but as the ground crew will attest it is certainly no featherweight!). Upon receipt of various suggestions (most of which were ignored and some were too rude to report) the sizzle has expanded to include cool drinks and more recently tea, coffee and soup, made possible by the generous loan of a bush urn, a family heirloom of the Kinnersly Clan. Due to the high ratings the Sizzle Saga is planning a seguel for the Sunnyside event and the all star billing will include tea coffee bacon and egg rolls for breakfast at scrutineering and hot dogs and cool drinks for lunch at the finish.
